

Privacy Policy for CamOptimization Fusion 360 Add-In

Automated Viking LLC ("we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains how the CamOptimization Fusion 360 add-in ("the App") collects, uses, shares, and manages your data. By using the App, you agree to the terms outlined below.

1. Data Collection and Use

The App collects minimal data to optimize CAM operations within Autodesk Fusion 360's CAM workspace. Specifically:

- **Log Files:** The App generates two files stored locally on your device:
 - `camOptimization_events.log`: Contains timestamps, operational details (e.g., optimization steps, errors), and debugging information.
 - `centroids.csv`: Records optimization data, including setup/operation names, spindle speeds, feed rates, stepdowns, stepovers, and centroid Z-heights.
- **Preset File:** The App creates `presets.json` to store user-defined presets (e.g., MRR, chip loads, spindle speeds, chamfer widths, engrave depths).
- **Storage Location:** Files are saved in the App's installation directory (e.g., where `CamOptimizationAddIn.py` is located) or the system's temporary directory (e.g., `%TEMP%\camOptimization_log.log` on Windows) if permissions are restricted.
- **Purpose:** These files track optimization processes, save user preferences, provide debugging insights, and allow users to review CAM parameters for traceability. No personally identifiable information (PII) is collected, as data is limited to geometric and operational metadata (e.g., coordinates, tool settings).
- **Collection Method:** Data is automatically generated during App usage and stored locally. The App does not access Autodesk account details, user IDs, or other PII from Fusion 360.

2. Data Sharing with Third Parties

The App does not share any data with third parties, including analytics tools, advertising networks, third-party SDKs, or affiliates of Automated Viking LLC. Log, CSV, and preset files remain on your device and are not transmitted externally. As no third-party sharing occurs, there are no third-party data protection obligations.

3. Data Retention and Deletion

- **Retention:** Log, CSV, and preset files (camOptimization_events.log, centroids.csv, presets.json) are retained indefinitely on your device unless manually deleted. They are stored in the App's directory or the system's temporary directory.
- **Automatic Deletion:** Files in the temporary directory may be removed by the operating system's cleanup processes. Files in the App's directory persist until the App is uninstalled or manually deleted.
- **Manual Deletion:** You can delete these files at any time by navigating to the App's directory (or temporary directory) and removing camOptimization_events.log, centroids.csv, and presets.json. Uninstalling the App via Fusion 360's Scripts and Add-Ins dialog removes files in the App's directory but not those in the temporary directory.

4. Revoking Consent and Requesting Data Deletion

- **Revoking Consent:** As the App collects no PII and operates locally, there is no ongoing data collection requiring consent beyond App usage. To stop data collection, cease using the App or uninstall it via Fusion 360's Scripts and Add-Ins dialog.
- **Data Deletion:** To delete collected data, manually remove camOptimization_events.log, centroids.csv, and presets.json from the App's directory or temporary directory. Locate the App's directory via Fusion 360's Scripts and Add-Ins dialog or check the temporary directory (e.g., %TEMP% on Windows, /tmp on macOS).
